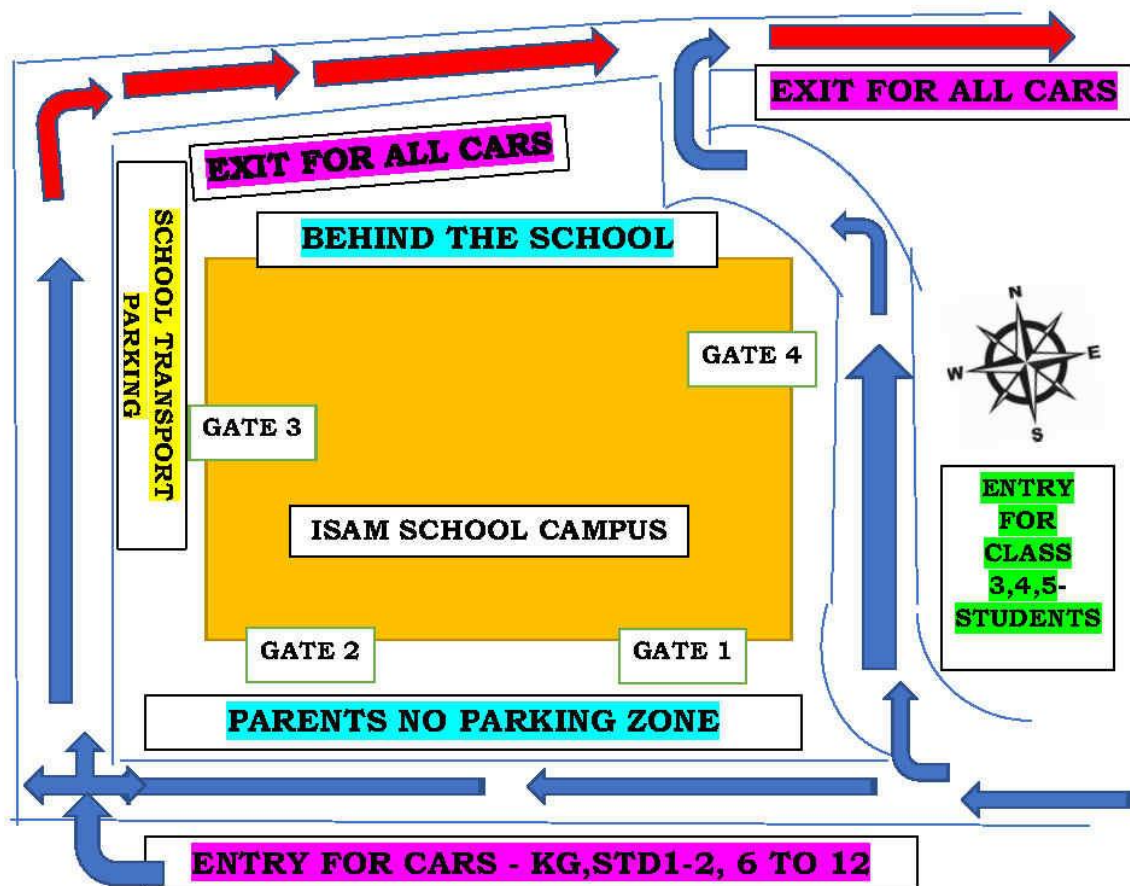

Traffic Management Guidelines

With reference to the circular **ISAM/CR/ADM/2021- '22/057** dated **12 January 2022**, would emphasize that the reckless driving of some of the transporters plying back and forth with the students poses a high risk and causes great concern.

The people who are operating within the school arena, inclusive of staff, students, visitors and the school community are requested to follow the below mentioned guidelines to ensure safe environment.

- Transporters are expected to keep the speed of the vehicle **(20 kmph on the school road & 10 kmph in the parking area)** to the minimum as they near the school arena.
- Drive with utmost care bearing in mind the safety and security of the students inside the vehicle as well as the students outside.
- Stakeholders are requested to park their vehicles behind the school ground (near to Kho Kho court / behind MPH)



➤ Strictly follow the traffic guidelines issued by the **ROP, Sultanate of Oman**. We seek everyone's cooperation to adhere to the traffic management plan for the safety of the school community.

Mode of Fee Payment

1. **Cash counter at the school**- Parents can choose either cash or bank cards (debit/credit) for fee payment at the school fee counter.
2. **E-payment gateway in the school website/TMS Mobile APP**- The school has introduced a new fee payment option for the convenience of the parents to pay the school fee without visiting the school. - b) Bank Muscat Account to Account Fund transfer (by mentioning the correct student GR/Admission Number and fee term in the "remarks" column of the transfer page).
